



MANUFACTURER'S WARRANTY

Eurorite Cabinets Ltd. warrants all parts and products manufactured to be free of substantial defects in materials and workmanship for a period of five (5) years and (1) year on painted doors, from date of purchase and under normal home use. In addition, Eurorite Cabinets Ltd. extends a lifetime warranty through its suppliers specifically on all hinges and drawer glides.

This warranty is only extended to the original purchaser, is subject to proof of purchase and may not be transferred to any subsequent owner. Warranties do not apply to products used for rental, commercial, business, institutional, or other non-residential applications. The warranty is determined at the sole discretion of Eurorite Cabinets Ltd. and at Eurorite's option limited to repair, replacement, or substitution of parts and/or products found to be defective under normal indoor residential use. Refunds are not available.

In no event will Eurorite Cabinets Ltd. be liable for any loss or damage of any kind including but not limited to any indirect, special, incidental, or consequential damages arising from the use of this product by any person.

Eurorite Cabinets Ltd. makes every effort to use the best materials & manufacturing techniques available, with continuous improvements. Eurorite reserves the right to change specifications in design and materials without notice and with no obligation to retrofit products previously manufactured.

Eurorite Cabinets Ltd. shall not be liable for any loss or damage of any kind including but not limited to any indirect, special or consequential damages arising from the use of this product by any person.

Limitations:

This is a parts-only warranty and is only valid in Canada and the United States of America.

This warranty does not cover:

1. Labour, installation or transport costs.
2. Consequential or incidental damage or any damage or errors resulting from or related to the transport, removal, installation or use of product.
3. Faulty installation.
4. Environmental influences such as water, humidity absorption, mold, UV rays, light exposure or extreme temperature.
5. Incorrect storage, delivery, or handling.
6. Any altered, modified, or refinished product.
7. Normal wear and tear or misuse.
8. Any product moved from its original installed location.

Excess moisture is harmful to any finish & substrate material. Water should be dried off of doors immediately with a dry soft cloth. Avoid water settling against the bottom of toe kicks, panels & doors as it will cause the material to swell.

Although a painted finish is very hard, it also can be susceptible to chipping due to an abrupt impact. Once a chip has occurred, the bond between paint & surface is compromised and can sometimes flake away easily unless repaired.

This isn't a manufacturing flaw; it's the nature of the product. A touch up kit should be purchased with all painted doors.

Cabinetry performance is susceptible to heat and steam damage. Industry standard clearances for ranges, wall ovens, and appliances that produce steam should be adhered to avoid damage to cabinetry. Heat deflectors/shields are recommended for use adjacent to ranges. During the self-cleaning operation of ranges, cabinet doors and drawers adjacent to that appliance should be opened to increase airflow and prevent damage.
